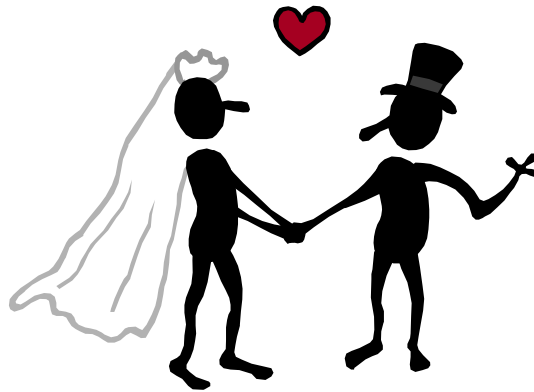

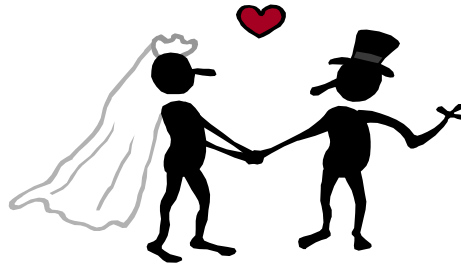

WEDDING TERMS AND CONDITIONS

BOOKING

- Provisional bookings can be held for up to 2 weeks at which time it is at the Hotel's discretion to release the booking should confirmation not be received.
- To secure a booking the non-refundable booking deposit of €???
- and the signed contract is required.
- All booking details and menus should be confirmed 3 weeks prior to arrival, should a menu not be chosen the hotel has the right to pre choose a suitable menu on your behalf.
- All prices quoted are 2009 rates; please note an additional fee will be applicable for all 2010/11 bookings.
- The latest meal serving time for wedding receptions is 6.00pm.
- It is the policy of the hotel that all bills must be settled on departure by bankers draft, credit card or cash only.
- Catering numbers are required 2 weeks prior to arrival and a 10% deviation is given without cancellation charge on final numbers required 72 hours prior to arrival, full charges apply there after.
- The evening buffet should be booked for a minimum of 70% of the total number of guests attending.
- Should you require a bar extension, minimum 6 weeks notice is required. This charge is non transferable or refundable.
- Children attending wedding receptions must at all times be kept under strict supervision by Parents/Guardian and are restricted to the banqueting suite only.
- The hotel has the right to refuse/refund deposits in circumstances when a booking is made by a third party or under false pretences. Prospective clients must always meet a member of management by appointment prior to acceptance of a deposit. The hotel may cancel the event in circumstances where the hotel has reason to believe that the booking might prejudice the reputation of the hotel

should the hotel believe any guests attending the event may behave in any way considered to be detrimental, offensive or contrary to normal expected behaviour.

▪ **ACCOMMODATION:**

- An allocation of 10 bedrooms will be reserved for the bridal party with a special discounted wedding rate available. The rooming list should be provided 3 weeks prior to arrival with a guarantee of payment for each room.
- The Bride and Groom can reserve for the wedding guests to book rooms directly with the hotel or through them.
- All bedrooms must be guaranteed by a credit card or a €30 deposit per person.
- Check in is guaranteed from 3.00pm and departure time is 12 noon. Should you require a later departure please contact reservations prior to your arrival.
- Car Parking is inclusive in your bedroom rate.

GENERAL

- All prices quoted are in Euro, valid for 2009 and are fully inclusive of VAT, may be subject to proportionate increases according to rises of food, labour costs, government taxes, VAT or any new Government levy or unforeseen circumstances. For 2009 bookings allow a 5% increase.
- There is no service charge in the Hotel.
- The Hotel will not accept responsibility for any goods lost, damaged or stolen, while on the premises.

- The Hotel policy and Government Health Regulations state that all food consumed on the premises must be prepared on the premises, with the exception of a Celebration Cake.
- Any damage caused to the property of the Hotel by the client or their guests will be calculated and billed to the account.

CANCELLATION

- The hotel may cancel the event only under the following circumstances:
 - The hotel has reason to believe the booking might prejudice the reputation of the hotel.
 -
 - The hotel receives evidence of any adverse alterations on the client's financial situation.
 - In the unfortunate event that the client requires to cancel a confirmed booking, the hotel will make every reasonable effort to resell the facilities on the client's behalf.
- 48 hours notice is required to cancel bedroom reservations, otherwise the full cancellation charge applies.
- In the unfortunate event that the client requires to cancel a confirmed booking the following cancellation fees apply:
 - 20% value of the booking 3 month prior to arrival.
 - 50% value of the booking 2 months prior to arrival.
 - 75% value of the booking 1 month prior to arrival.
 - 100% value of the booking 2 weeks prior to arrival.
